**Authority:** U.S. Public Law 90-618 (Gun Control Act of 1968); 10 USC 3012

**Principal purpose(s):** To evaluate an application for registration of a privately owned firearm and to issue a registration on establishment of eligibility.

**Routine use(s):** a. To verify the registration status of a firearm for law-enforcement purposes.

b. To establish ownership of firearms for investigative purposes.

c. To serve as a preliminary requirement for export of a privately owned firearm from Germany.

d. To serve, in some cases, as an approval document for purchase of firearms.

e. See routine uses set forth at 40 Federal Register 35151.

**Mandatory or voluntary disclosure and effect on individual not providing information:** The disclosure of personal information is voluntary, including social security number (SSN). Failure to provide any item of information will result in rejection of the application. Unregistered firearms are subject to impoundment or confiscation.
